Funding Request – Long Term Recovery**

If you and/or your business have been affected by 2020 Jonesboro Tornado Disaster, you may be eligible for assistance from the Recovery & Rebuilding Fund. If you are filing for both home and business disaster assistance, you will need to complete 2 separate registrations for the losses. (Please note: Funding will generally not exceed \$5,000.00). All funds will be paid directly to service providers and/or attach receipts for services already completed, not reimbursed in some other way. Those providing construction must have a City Privilege License & contractors must have an Authorized Contractor Tag from the city. Application is due Sept. 14, 2020.
